



### Vice-Chancellor’s Africa Scholarship 2022-2023

#### Key Facts Document

This Key Facts Document sets out the main details of the Scholarship, as at date of publication.

<b>Date of publication</b>	January 2022
<b>Application Process</b>	There is no application form for this scholarship. The Admissions Team at the University of Dundee use information provided in applicant’s course application to determine if they are eligible to receive this scholarship.
<b>Who is eligible?</b>	<ul style="list-style-type: none"> <li>• Hold an offer to study an eligible Undergraduate or Postgraduate Taught course at the University of Dundee <ul style="list-style-type: none"> <li>○ Undergraduate - Must hold an offer for a full time, on campus course excluding any course in the School of Medicine or Dentistry. <ul style="list-style-type: none"> <li>○ Postgraduate taught - Must hold an offer for a full time, on campus course in any academic school.</li> </ul> </li> </ul> </li> <li>• Classified by the University of Dundee as an International Fee-paying student.</li> <li>• The course must be a full time, on campus course. <ul style="list-style-type: none"> <li>○ Undergraduate courses of 120 credits per year of study</li> <li>○ Postgraduate courses of 180 credits per year of study.</li> </ul> </li> <li>• PhD and Masters by Research courses are <b>not</b> covered by this scholarship.</li> <li>• The course must have a tuition fee of: <ul style="list-style-type: none"> <li>○ £19,500 (Undergraduate) or;</li> <li>○ £19,900 (Postgraduate Taught), or above</li> </ul> </li> <li>• <b>Courses at a lower fee are not eligible*</b></li> <li>• Domiciled in <ul style="list-style-type: none"> <li>○ <b>Africa</b> - Algeria, Angola, Benin, Botswana, Burkina Faso, Burundi, Cameroon, Cape Verde, Central African Republic, Chad, Comoros, Congo, Ivory Coast, Djibouti, Egypt, Equatorial Guinea, Eritrea, Ethiopia, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Kenya, Lesotho, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Mauritius, Morocco, Mozambique, Namibia, Niger, Nigeria, Rwanda, Sao Tome and Principe, Senegal, Seychelles, Sierra Leone, Somalia, South Africa, Sudan, Swaziland, Tanzania, Togo, Tunisia, Uganda, Zambia, and Zimbabwe.</li> </ul> </li> </ul>



<b>Award Information</b>	<ul style="list-style-type: none"><li>• The value of this scholarship is £5,000 per year of study (up to a maximum of 5 years at £25,000) and is awarded as a tuition fee waiver. The maximum award amount is £5,000 each academic year.<ul style="list-style-type: none"><li>○ Undergraduate – Up to a maximum of 5 years (£25,000).</li><li>○ Postgraduate Taught – Where the course spans more than 12 months full time, the scholarship will be applied in both years of study where full tuition fees are charged (£19,900 or above per year).</li></ul></li><li>• All scholarship awards are offered on an unconditional basis.</li><li>• All scholarship awards are deducted from tuition fees and are not paid directly to any applicant.</li></ul>
<b>Key Information</b>	<ul style="list-style-type: none"><li>• If an applicant has an Offer for a 3.5-year Undergraduate course in the School of Business, then the scholarship will only be applied from Year 2 onwards.</li></ul>
	<ul style="list-style-type: none"><li>• Where eligible, this scholarship can be combined with the following scholarships:<ul style="list-style-type: none"><li>○ Alumni or Alumni Family</li><li>○ Discover Business at Dundee</li></ul></li><li>• ‘Domiciled’ means the country of residence at point of application, or an applicant’s corresponding home address. This information must be provided at point of course application.</li><li>• If you are abroad at the time of your application, country of domicile will be determined by the country of your ‘home’ residence.</li><li>• ‘Domiciled’ does not reference an applicant’s Nationality or Citizenship.</li><li>• Applicants in receipt of a Vice-Chancellor’s Africa/EU/South Asia Scholarship are not eligible to also receive the Global Excellence Scholarship.</li><li>• Applicants in receipt of a Vice-Chancellor’s Africa/EU/South Asia Scholarship are unable to apply for the Global Citizenship Scholarship.</li><li>• If an applicant has an external scholarship which covers the full tuition fee, then they are no longer eligible to receive a Vice-Chancellor’s Regional Scholarship. The University will not pay any money directly to the applicant and the award cannot be transferred.</li><li>• Applicants in receipt of a Vice-Chancellor’s Scholarship may also be eligible for other funding. All applicants are encouraged to review the Scholarship Terms and Conditions to confirm Scholarship combination options.</li><li>• All communication with the applicant will be via email, and to their @dundee.ac.uk email address. We may also communicate with other email addresses provided to us by the applicant.</li><li>• If an applicant has funding as part of a partnership agreement, then they cannot hold a Vice-Chancellor’s Regional Scholarship in addition to this. The higher value award will apply.</li><li>• If an applicant chooses to defer their entry within the same academic year, we may be able to defer the scholarship award. However, this may not apply if the applicant chooses to defer to the following academic year. We will confirm with all applicants who defer, the status of their scholarship.</li></ul>



	<ul style="list-style-type: none"><li>• If an applicant has paid their tuition fees in full prior to being awarded a Vice-Chancellor's Regional Scholarship, the value of the scholarship will be refunded to the applicant after they have enrolled at the University of Dundee. Alternatively, this can be transferred to the University accommodation account balance (if applicable).</li><li>• If an applicant receives the award after the University of Dundee has issued a CAS for visa application purposes, then the applicant will need to get in touch with the University to confirm next steps.</li><li>• The scholarship is only awarded in the years in which full fees (£19,900 and above) are paid to the University.</li><li>• If a student re-sits a year of study at the University, the scholarship award will not apply, however will commence once they have progressed to the next level.</li><li>• Applicants from non-graduating years at the University are not eligible for the Scholarship.</li><li>• The University of Dundee will not back date any awards and all awards made will be current and apply to the applicant in the 2022-2023 academic year. The University of Dundee will not make awards to students who have already enrolled at the University onto their course of study.</li></ul>
	<ul style="list-style-type: none"><li>• If an applicant withdraws from their course of study, the University Fees department will be in contact regarding payment of fees and scholarship balance.</li><li>• The University reserves the right to withdraw the scholarship immediately and without notice where the student is determined by the University to have misled the University about any aspect of eligibility to receive the scholarship.</li><li>• Clearing applicants are not eligible for this award.</li><li>• All scholarship decisions are final and cannot be appealed.</li></ul>
