## Student Voice Support Officers (SVSO)

SVSO's are a team of current students and recent graduates who work for DUSA but are employed to support the engagement system at the University. The role has four main priorities:

- To lead student representative training workshops which ensures representatives have the required skills and knowledge to effectively represent their peers
- Support students in quality processes by working with staff teams to engage representatives and other students to take an active role in feeding in their experience. This includes briefing student representatives and conducting consultations and other feedback mechanisms
- Helping to engage student representatives within the SRC to bring forward their ideas for improvement and aid taking agreed areas of work forward
- Supporting activities identified through the Student Partnership Agreement (SPA) including conducting research, engaging students and other actions that meet the agreed objectives

The SVSO team are managed by DUSA's Democratic Support & Policy Coordinator with oversight from the Vice President of Representation and Director of Quality & Academic Standards.
