#### **Scottish Government (Research Commission)**

The report has been submitted and was presented to the Committee on 1st March. The report is due to be published in May/June of this year.

# International Woman's Day invited presentation at Durham University

Dr Stephanie Schreven was invited to present her work titled: 'Re-reading Frankenstein as a socially progressive tragedy to 'break the bias' at Durham University on 8th March. The theme of this year was 'breaking bias' which referees to stereotypes, prejudice, and such like. The paper argues in favour of practicing 'vulnerable recognition' in practicing solidarity in equality with monsters and freaks. Vulnerable recognition asks us to challenge our internalised, at times wilful ignorance and indifference towards those who are different, by asking difficult questions of ourselves, including among women, in how we are implicated in maintaining oppressive, discriminatory, exclusionary norms and practices as well as unjust social arrangements.

NHS Tayside Chief Executive Grant Archibald has been appointed Honorary Professor in the University of Dundee School of Business. #### Mr Paul Caulfield

#### 1. Where are you from? Tell us a little about your background in a few sentences

I am originally from the West of Scotland but moved to England to study Accounting and Finance at the University of Birmingham. I then trained to be a secondary school teacher in London and taught Business Studies and Economics at school level for the remaining years of my twenties. In my thirties I left teaching and trained and qualified as a Management Accountant and worked for the NHS and then the BBC as a Management Accountant. Later in my thirties I emigrated to Australia and worked as a Business Analysis at Sydney Opera House. When I returned to the UK I worked for the RAC as a Financial analysts before returning to teaching in my early forties at Birmingham City University as a Lecturer. Last year 2021, I decide to relocate back to Scotland and accepted the offer of employment at UOD.

#### 2. What are your main areas of research interests?

Based on my combined experiences as a Teacher and a Management Accounting and the varying levels of experience I had with being trained as an Accountant I wanted to investigate the process of developing effective short term focussed management accounting training that meets the training needs of the participants. There is a wide body of literature and studies and significant interest in this field, especially since the rise in popularity of online courses.

### 3. What are your most significant research contributions to date? to academics, to policy and/or practice

Preliminary results in this study during pilot and early studies undertaken at Birmingham City University during the early stages of my Doctorate work have had an impact with relevant professional bodies and commercial training companies who have been interested in the work I have been doing in building a framework model for effective accounting training as well as other HE Institutions such as BCU as well as European partnership institutions who I have collaborated with in developing the concepts and techniques for this framework. I have also presented my preliminary results to several conferences domestic and international.

#### 4. What are your research and/ or impact aims over the next few years?

The immediate and fundamental aim over the next two years is to formally complete my PhD in relation to this research. I will continue to present findings to conferences and present papers. Other related articles will be developed either solely or in collaboration with other interested parties.

#### **Dr Lee Roberts**

#### 1. Where are you from? Tell us a little about your background in a few sentences

I joined the University of Dundee in January 2022 after completing my PhD at Brunel University in London. Before Brunel, I gained a BAcc in Accounting at The University of the West of Scotland.

#### 2. What are your main areas of research interests?

My main research area is Biodiversity and Extinction Accounting. To date, my research focuses on corporate disclosures and accountability for biodiversity and species extinction. I am also interested in research on Circular Economy reporting practices.

### 3. What are your most significant research contributions to date? to academics, to policy and/or practice

My research on Biodiversity and Extinction Accounting has been published in Business, Strategy and the Environment, Journal of Business Ethics, and Corporate Social Responsibility and Environmental Management.

#### 4. What are your research and/ or impact aims over the next few years?

My research over the next few years is to further develop impactful research on Biodiversity and Extinction Accounting by examining industry, country and firm specific cases. This research aligns to achieving the United Nations Sustainable Development Goals by 2030. I am also currently working on research on Circular Economy reporting practices of companies.



#### **Dr Rongrong Sun**

#### 1. Where are you from? Tell us a little about your background in a few sentences

I grew up in China and had all my high education in economics (BSc, MSc and Doctor, with the latter obtained in 2013) in Germany. Prior to joining the University of Dundee School of Business, I worked at the University of Nottingham Ningbo China and Henan University (in China).

#### 2. What are your main areas of research interests?

I am an applied economist, with the main research interests in monetary policy, macroeconomics, and the Chinese economy.

### 3. What are your most significant research contributions to date? to academics, to policy and/or practice

My main contributions to the literature include two narrative indices (to measure the policy stance of Chinese monetary policy and Chinese macroprudential policy, respectively) and a series of papers to examine the impact of Chinese monetary policy, published in Journal of Banking & Finance, International Journal of Central Banking, and Journal of International Money and Finance. In practice, I worked as a visiting fellow at the central banks' research institute and had projects carried out there (the Hong Kong Institute for Monetary and the Bank of Finland Institute for Economies in Transition).

#### 4. What are your research and/ or impact aims over the next few years?

I have several projects on monetary policy in the pipeline. Also, I am working on the projects on household financing, corporate financing, and the psychological health of left-behind children, using household- and firm-level data
